



PREK-12 PROGRAMS RULES AND GUIDELINES

ELIGIBILITY:

You must be a citizen of the Gun Lake Tribe, between the ages of 3-18, and enrolled in school.

You must have the following items on file in the Education Office:

* A completed 2020-2021 Johnson O'Malley Survey

PREK-12 PROGRAMS:

The PreK-12 Programs are funded by the Revenue Allocation from the Gun Lake Casino.

Clothing – Each student is eligible for \$200 for school clothes per semester. Clothing items include clothing that can be worn to school, winter coats, hats, snow pants. Items that are not eligible include accessories, fashion hats, pajamas, etc.

1st Semester Receipts must be *dated*: **JULY 2—December 31**.

2nd Semester receipts must be *dated*: **JANUARY 1—JUNE 1**. Receipts will no longer be accepted after July 1.

School Supplies – Each student is eligible for \$200 for the purchase of school supplies, either picked up during back to school event or sent out at the beginning of each school year.

School Pictures – Each student is eligible for \$50 towards the purchase of school pictures per school year. Only school sponsored pictures will be accepted for reimbursement. Receipts must be dated between August 1 and June 1st.

School Yearbooks – Each student is eligible for \$50 towards the purchase of a school yearbook per school year. Receipts must be dated between August 1 and June 1.

High School Seniors – Receipts must be dated between August 1 and June 1.

Senior Package—up to \$200 towards your cap and gown, graduation announcements, etc.

Senior Pictures—up to \$250 towards the purchase of your senior pictures.

Grad Night—up to \$100 towards payment for your graduation night festivities.

Grade Incentives – Kindergarten-12th grade students can submit their report cards for a grade incentive. Student must have a 3.0 GPA or higher. Report Cards must be for Semester or Trimester grades only. Progress Reports or Marking Period reports will not be counted. Incentives will only be **paid twice per school year**. Preschool students are only eligible for the Perfect Attendance Incentive.

K-4th grade will receive \$50

5-8th grade will receive \$75

9-12th grade will receive \$100

Perfect Attendance – Students who complete a full semester or trimester without any excused or unexcused absences will receive a \$100 Perfect Attendance Award.

JOHNSON O'MALLEY (JOM):

Johnson O'Malley is funded by the 638 Contract through the Bureau of Indian Affairs. You must purchase at least one pair of tennis shoes.

1st Semester receipts must be *dated*: **JULY 2 – JANUARY 1**

2nd Semester receipts must be *dated*: **JANUARY 1 – JUNE 1**. Receipts will no longer be accepted after July 1.

Students Preschool-8th grade receive up to \$75 per semester.

Students 9-12th grade receive up to \$125 per semester.

EDUCATION ENRICHMENT PROGRAM (EEP)

The Education Department will pay up to \$2000 per school year for tutoring and/or private education for your child. You must submit the EEP Application, a letter stating how your child will benefit from private education or the use of a tutor, as well as an invoice from the school or tutor or your receipt of payment.



NEW UNDER EEP PROGRAM!!!! – LAPTOP ASSISTANCE

Education will work with the GLT IT department to coordinate the purchase of a laptop on behalf of citizens that will then be distributed directly to the most recent address on file with Enrollment.

Please note that the purchase of the laptop counts towards the 2K budgeted annually for each K-12 citizen through the EEP program. (not in addition to)

We understand the need for immediate access. Therefore, if you need to purchase your student a laptop immediately, we can reimburse you up to the current total amount we would have paid for the computer being offered to students through this program.

What is needed : A completed EEP application (tuition) and documentation of need such as a letter from your district indicating that your student is participating in remote learning and will not be provided a laptop.

ONE LAPTOP PER CITIZEN – ONCE EVERY THREE YEARS

ENRICHMENT FUND (FORMERLY THE RECREATION FUND)

The purpose of the Enrichment Fund is to offer financial assistance to Gun Lake Tribal Citizens who participate in enrichment activities such as sports, performing arts, school activities, gym, museum, zoo, and recreation facility memberships, driver's training, etc. You must submit a Recreation Fund application, a letter stating the need for assistance, paperwork stating program information and price, and a receipt or invoice for payment.

Citizens age 17 and under are eligible for up to \$300 per fiscal year (October 1—September 30)

Citizens age 18 and older are eligible for up to \$150 per fiscal year (October 1—September 30)

HOW TO APPLY FOR REIMBURSEMENT:

You must submit a receipt/invoice for all items purchased. Receipts must be **clearly labeled** with the child's name, and type of items purchased (Clothing/shoes). All items must be shown on receipt. **Images only showing receipt total will not be honored.**

For ease of processing, please clearly label your receipts. Each receipt must be labeled with the child's name and the type of item purchased. If your receipt is not properly labeled, it will be sent back to you to be redone. If possible, make each child's purchases separately. Do not send multiple copies of the same receipt.
